 - Request from the <u>Polish delegation</u>

The <u>SCA</u> took note of the request made by the <u>Polish delegation</u>, supported by the <u>Czech delegation</u>, on the need for the SCA to discuss the Commission proposal for a Regulation laying down the rules and general principles concerning the mechanisms for control by Member States of the Commission's exercise of implementing powers (doc 7386/10) which is currently under examination by the <u>Friends of the Presidency Group</u>. The <u>Presidency</u> indicated its intention to reflect on this request.

EU Trade negotiations with Mercosur

- Request from the Polish delegation

The <u>SCA</u> took note of the joint request made by the <u>Irish, Greek, French, Hungarian,</u> <u>Austrian, Polish and Finnish delegations</u> and supported by the <u>Cypriot and Romanian</u> <u>delegations</u> to include an AOB item on the agenda of the next Council meeting on 17 May 2010, on the "EU trade negotiations with Mercosur countries".
